# About the Global Village – an effective platform for international delegations

The Global Village is a platform hosted by the Swiss Biotech Association in partnership with other Swiss organizations who engage in worldwide networking in biotech and international collaboration in biotech and life sciences.

It provides a dedicated offering for national and regional delegations from foreign biotech clusters who wish to develop and strengthen long-term and sustainable business ties and collaborations with various stakeholders of the Swiss biotech ecosystem.

The yearly Swiss Biotech Day serves as the anchor event for the Global Village platform. The Global Village platform, however, aims at continuous and sustainable collaboration, concrete action plans for collaboration with impact and collaboration with mutual benefit for all involved.

The platform offers a multitude of opportunities to engage, from initial offerings to learn about the diversity of the Swiss biotech ecosystem, through partnering and the exploration of collaboration opportunities, to concrete activities and long-term engagements.

During the Swiss Biotech Day, it offers country or regional partnering booths, the opportunity to participate in the partnering platform and participation at the international reception. Optionally, and depending on the delegation's interest, it offers a bilateral roundtable discussion, a dedicated market-place reception, the opportunity to contribute in various ways to the conference and the option to participate in side visits to facilities and stakeholders at Biotech hotspots across Switzerland - before or after the Swiss Biotech Day

Since the platform was initiated in 2022 many delegations from North and South America, Asia, Australia, and Europe have engaged in the Global Village and outlined successfully essential steps to move collaborations forward.

## Join them to explore and deepen your collaboration with the Swiss biotech ecosystem:

- engage with Swiss biotech entrepreneurs, CEOs and investors
- explore collaboration opportunities with Swiss biotech decision makers
- facilitate cross-border investments
- establish public/private partnerships
- strengthen academic and R&D collaborations
- foster talent exchange
- shape policies of common interest

# Benefits for delegations and ways to engage in the Global Village platform

#### International delegations benefit in many ways:

- Great visibility and many outreach opportunities to other global partners at country or regional booths, on the partnering platform and onside as well as the international networking reception. The last Swiss Biotech Day attracted over 1,800 participants from 40+ countries.
- Focused opportunities for engagement through tailormade roundtable discussions, marketplace networking and side visit offerings adjacent to the Swiss Biotech Day.
- International delegations can actively participate in the Swiss Biotech Day program and thus increase their visibility through pitching and panel discussions.
- Follow-ups before and after the Swiss Biotech Day to develop sustainable longer-term engagement plans and meetings at either international BIO conferences or through ad hoc follow-up discussions.

#### How to participate in the Global Village

The Global Village is open to national and regional biotech clusters. Each delegation needs to designate a lead and co-lead who act as a point of contact and coordinate the delegation:

- Identify delegation members, facilitate their participation, and coordinate the delegation activities
- Source the budget needed to cover participation and attendance costs
- Coordinate the preparation of optional formats like roundtable discussions, conference contribution, side visits

- Coordinate meetings before/after the Swiss Biotech Day
- Plan follow-on activities for 12 months after the event

Interested foreign parties who would like to be part of a foreign delegation are welcome to contact us and express their interest.

Equally, we invite Swiss companies with links to foreign leading ecosystems to signal their interest if they would contribute to contribute to the Global Village efforts.

#### How to compose the delegation effectively

Identifying delegation members with an existing link to or strong interest in Switzerland and the Swiss biotech ecosystem facilitates the engagement success significantly.

To enable an effective participation and contribution to the Global Village platform it is essential that the delegation includes decision makers, such as

- Biotech investors, venture builders
- Biotech entrepreneurs (C-level)
- Leading hospitals, clinical investigators, CROs
- Universities and private research centres
- Government bodies with vested interest, for example regulatory agencies
- Incubators and accelerators, talent developer

## Organisational Details

The size of the Global Village delegation determines the choice of available exhibition space and ticket numbers. Being part of the Global Village offers members of a delegation full access to the conference, the partnering platform and to the international reception.

- Tailormade visits can be arranged if communicated according to timelines and pending of availability of Swiss partners

## Marketplace, pitching sessions, conference contributions

Options are pitches for start-ups, dedicated marketplace session for delegations with many stakeholders and significant diversity, conference contributions on specific content of broad interest.
